Report of the Superintendent of Schools:

Act 46 – Statewide Plan Outcomes – The Agency of Education issued their recommendation. At this point it looks as though BVSU will remain the same until at least June 30, 2020. The next step would to attend the meeting being held at the Green Mountain High School in Chester on September 19, 2018.

Facilities Project – Matthew Bykowski wanted to report to the board member about the meeting he attended with Wright Construction & Black River Design. Two big issues: There was a small area of Asbestos at Fisher that needs to be taken care of. This cost would be \$14,830.00 The other issue is there is a "low slope" in the roof of the gymnasium at the high school. This would be a concern for ice / water. The recommendation from Wright Construction would be to install an ice & water barrier. This would prevent any further damage. This cost would be \$14,870.00. At this point in time the budget is still well within range so these new issues would not increase the budget that was allotted. The board members have agreed to go ahead with the two recommendations from Wright Construction and repair the asbestos problem at Fisher and install the ice & water barrier at Arlington Memorial High School.
